method found nearest- LT. network with the help of PVC wire which indicates use of electricity dishonestly and he is using electrical equipment fan, bulbs etc with the hooking device. As the theft of electricity was detected during inspection, we disconnected the unauthorised hooking line and seized the seizure article in proper seizure list on token basis. The local people refused to put signature in the seizure list. After completion the inspection we left the spot at 12.20 P.M.
