1... That the complainant is the citizen of India and he is the permanent resident of village Sindri, P.S. Baghmundi, District Purulia having his permanent place of abode in R.S.Plot No. 3429.

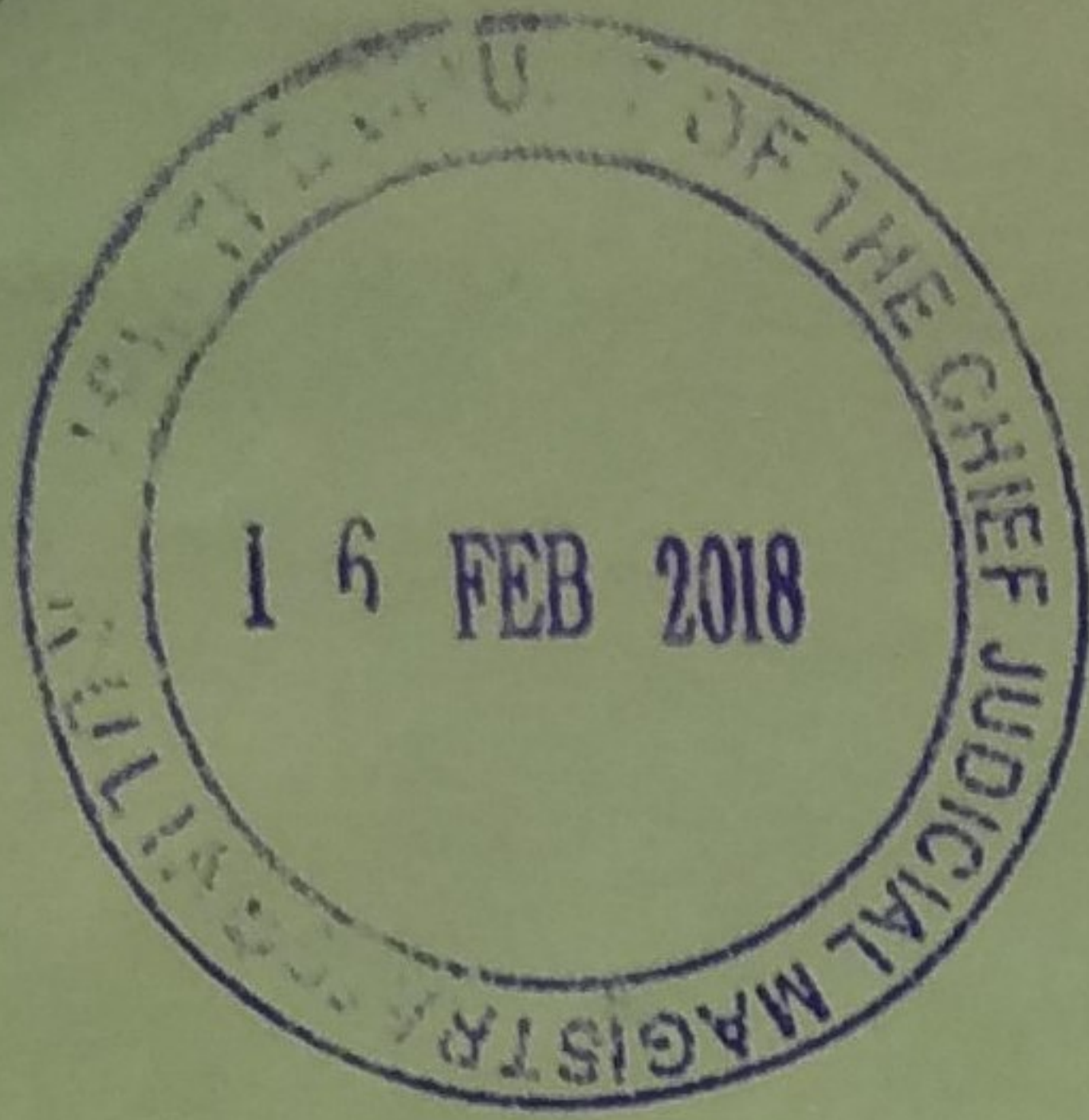
2... That it may be mentioned here that the land of Habib Ansari i.e. the father of the accused persons No. 1 2 and 3 and father in law of accused 4, 5 and 6, is situated just attached the house of the complainant.

3... That on the date of occurrence at about 8/9 morning all accused persons forcibly started to cut the Chala of the house of the complainant on the eastern side and they started to construct their pucca wall by attaching the mud well of the complainant's house.

4... That the complainant and the witnesses came to the spot and saw that the accused persons are cutting and damaging the country tiles challa of the complainant's house as a result of which the mud wall of the complainant's house will be damaged due to rain and the cow, goat, hen etc. will be died due to such mischief.

5... That the complainant and the witnesses requested the accused persons not to cause mischief of the complainant in such a manner but the accused persons became furious and attempted to attack the complainant by Sabal, Gainti and Kurul and the complainant saved himself some how. The accused Sarbesh assaulted the complainant by fists

blows and drove out the complainant from there.

6... That thereafter the accused persons have taken away wooden pole (Rola) tiles and to which the complainant sustained a loss of Rs. 5,000/- which the accused persons have caused mischief and damage.

7... That the complainant lodged diary about the incident took place on 6.12.2017 to the O/C Baghmundi P.S. who assured to start and investigate the case against the accused persons but he did not start the case and so the complainant on 9.2.2018 lodged complain before the S.P. Purulia praying for relief but till then, no case has been started and hence the complainant compelled to file this case before this court.

It is therefore prayed that your Honour would be pleased to send this petition of complaint to the O.C. Baghmundi P.S. for starting case ~~U/s 448/323/379/506/34 I.P.O.~~ against the all accused person and to investigate the same treating this as F.I.R. U/S 156(3) Cr.P.C.
