Yudhishir Paramanik, HCTSH 3. \_\_\_\_\_ entered the premises of Sri Ajembar Singhmura, S/O- Lt. Khepa Singhmura of village Chatus, P.O- Kalimati, Dist- Purulia and found Sri Ajembar Singhmura was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.12 KVA.
