In producing herewith the accused person namely Khudiram Kuiry (36 yrs) S/O- Lt. Nirmal Kuiry of Lengdih, P.S.-Baghmundi, Dist-Purulia along with seized articles 1) 15 (fifteen) sealed bottle of Dil Se Country spirit each bottle contains 600 ml CS, 2) Approx 20 litre of I/D liquor in a white plastic jarican, 3) 6 pcs of empty bottle of Dil Se Country Spirit, 4) 15 pcs of disposable plastic glass and 5) Rs. 85 /- as sale proceed which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 18/03/18 in between 19:45 hrs and 20:35 hrs a raid was conducted in the Grocery of Khudiram Kuiry (36 yrs) S/O- Lt. Nirmal Kuiry of Lengdih, P.S.-Baghmundi, Dist-Purulia acting on a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found the above noted person were keeping/ selling Country Spirit and I/D liquor which were kept in his Grocery at Lengdi village. On demand he failed to produce any valid documents in respect of stocking & selling of liquor. As such I arrested him U/S- 67 B.E. Act. and also 1) 15 (fifteen) sealed bottle of Dil Se Country spirit each bottle contains 600 ml CS, 2) Approx 20 litre of I/D liquor in a white plastic jarican, 3) 6 pcs of empty bottle of Dil Se Country Spirit, 4) 15 pcs of disposable plastic glass and 5) Rs. 85 /- as sale proceed were seized under proper seizure list duly sign by the witness which is enclosed herewith. During arrest the ground of arrest was duly notified, issued arrest memo U/S- 50 Cr.P.C and handed over a copy of the same to the arrested person. The above noted arrested accused person namely Khudiram Kuiry (36 yrs) S/O- Lt. Nirmal Kuiry of Lengdih, P.S.-Baghmundi, Dist-Purulia committed an offence U/S- 46 B.E. Act, 1909 for unauthorized possession and sell of Country Spirit from his grocery.

Under the fact and circumstances I, therefore, pray that a Case U/S- 46(A)(c) of B.E. Act. 1909 may kindly be started against the said accused persons namely Khudiram Kuiry (36 yrs) S/O- Lt. Nirmal Kuiry of Lengdih, P.S.-Baghmundi, Dist-Purulia
