Sub: Lodging F.I.R against Krishna Pada Majhi, S/o. Pashupati Majhi for unauthorized use of Electricity by way of hooking u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

I Sri Amitava Choudhury, S/O- Lt. Sajal Kr. Choudhury, A.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Krishna Pada Majhi, S/o. Pashupati Majhi resides at Vill — Bankudih (Upar Para), Po. Ghatbera, PS: Balarampur, Dist. Purulia to the effect that received an information that the aforesaid accused person is committing theft of Electricity in his residence by way of direct hooking from the LTOH Line of WBSEDCL.

Acting upon such information today on 15.03.2018 from 4.00 PM to 4.35 PM I, along with Sri Shanti Pada Gorain , H.Gr. Linesman , Sri Aloke Kumar Modak, TSH Balarampur CCC and technical persons of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) inspected the premises of Krishna Pada Majhi and held raid.

During raid and inspection it was detected that accused Krishna Pada Majhi is using electricity dishonestly by making direct hooking from the nearby LTOH Line of WBSEDCL for running 3 No. 100 Watt Lamp, 1 No. 60 Watt Lamp and 1 No. 20 Watt CFL having connected load 0.38 KW. There exists one Service Connection of WBSEDCL bearing Consumer ID: 201326608 stands recorded in the name of the Accused which was in disconnected condition due to nonpayment of energy bill.

I prepared Inspection report in presence of the Accused and assessed the Load as 0.38 Kw. Details have been mentioned in the Inspection Report and duly signed by the Accused.

I directed Sri Shanti Pada Gorain, H.Gr. Linesman to disconnect the hooking arrangement from our LTOH line. Accordingly he disconnected the aforesaid hooking arrangement from LTOH Line.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list and obtained the signature of the accused. A copy of the seizure list was handed over to the accused. The Local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offense u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused. Encl:
