Sir,

I Sri Amitava Choudhury, S/O- Lt. Sajal Kr. Choudhury, A.E & Station Manager of Balarampur CCC of WBSedcl do hereby lodge complaint against Buchan Majhi (Murmu), S/o. Kalipada Majhi (Murmu) resides at Vill - Bankudih (Nich Para), Po. Ghatbera, PS : Balarampur, Dist. Purulia to the effect that received an information that the aforesaid accused person is committing theft of Electricity in his residence by way of direct hooking from the LTOH Line of WBSedcl.

Acting upon such information today on 15.03.2018 from 4.40 PM to 5.15 PM I, along with Sri Shanti Pada Gorain, H.Gr. Linesman, Sri Alope Kumar Modak, TSH Balarampur CCC and technical persons of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSedcl) inspected the premises of Buchan Majhi (Murmu) and held raid.

During raid and inspection it was detected that accused Buchan Majhi (Murmu) is using electricity dishonestly by making direct hooking from the nearby LTOH Line of WBSedcl for running 2 Nos. 60 Watt Lamp having connected load 0.12 KW.

I prepared Inspection report in presence of the representative of the Accused and assessed the Load as 0.12 Kw. Details have been mentioned in the Inspection Report and duly signed by the representative of the Accused.

I directed Sri Shanti Pada Gorain, H.Gr. Linesman to disconnect the hooking arrangement from our LTOH line. Accordingly he disconnected the aforesaid hooking arrangement from LTOH Line.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list and obtained the signature of the representative of the accused. A copy of the seizure list was handed over to the representative of the accused. The Local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection report.

For this activity of theft the WBSedcl has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offense u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
