P.S - Balarampur, Dist - Purulia to the effect that received an information that the
aforesaid accused person is committing theft of electricity in his residence by way
of direct hooking from the nearby LTOH line of WBSEDCL.

Acting upon such information ~~today~~ yesterday on 7/3/2018 from 8:00 PM to 8:40 PM
I along with Sri Anup Mandal, SAE Balarampur CCC, Sri Amit Kumar Hela office Executive
Balarampur CCC and technical persons of M/s. Ajoy Kr. Ghosh (Entitled Agency of WBSEDCL)
inspected the premises of Magaram Mahato and held raid.

During raid and inspection it was detected that accused Magaram Mahato is using
electricity dishonestly by making direct hooking from the nearby LTOH line of WBSEDCL
for running 3 Nos Lamp having connected load of 0.26 kW.

I prepared inspection report in presence of the accused and assessed the load as
0.26 kW. Details have been mentioned in the inspection report duly signed by the
accused and Local witness.

I directed the technical persons of M/s. Ajoy Kr. Ghosh (Entitled agency of WBSEDCL)
to disconnect the hooking arrangement from our LTOH line. Accordingly the disconnected
the aforesaid hooking line from LTOH line.

On enquiry it is gathered that the accused Sri Magaram Mahato resides at ~~vill Rango~~ vill - Rangadungri Malti, P.S. Balarampur to a premises which is actually owned by one Bhubaneswar Prasad Gupta. The Permanent Address of Sri Magaram Mahato is at vill - Kudlung, P.S. Hurra Dist - Purulia.

For his activity of theft the WSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135 (i) (a) of Electricity Act 2003 (with up to date Amendment).

Kindly treat this complaint as FIR and take necessary action against the accused.
