Chatterjee, resident of Balarampur Sakra para, Rangadih, Purulia, came to my house on 02.03.2018 at about 12-30. P.m and forced me to withdraw my divorce suit as prayed before the honorable court (C.J.M) immediately. On being refused by me, he started to assault me physically hurling inaudible obscene language at me publicly. He also threatened me to murder me at any time unless I withdraw the divorce suit. For the matter of which I am passing my days with terror and suspense.
