Sub: Lodging F.I.R against Sk. Habibul @ Habibul Ansary, S/o. Lt. Sk. Muslim for unauthorized use of Electricity by way of bypassing the Energy Meter u/s 135(i)(a), (i)(c) & (I) (e) of Electricity Act 2003 (Amended in 2007).

Sir,

I Sri Amitava Choudhury, S/O- Lt. Sajal Kr. Choudhury, A.E & Station Manager of Balarampur CCC of WBSSEDCL do hereby lodge complaint against Sk. Habibul @ Habibul Ansary, S/o. Lt. Sk. Muslim resides at Vill - Genrua, Po. Genrua, PS : Balarampur, Dist. Purulia to the effect that received an information that the aforesaid accused person is committing theft of Electricity in his tailoring shop by way of tapping the incoming service cable to bypass the proper registration of units in the Energy Meter of WBSSEDCL.

Acting upon such information today on 19.03.2018 from 4.50 PM to 5.30 PM I, along with Sri Anup Mandal, S.A.E, Sri Arindam Chatterjee, O.E Balarampur CCC and technical persons of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSSEDCL) inspected the premises of Sk. Habibul @ Habibul Ansary and held raid.

During raid and inspection it was detected that accused Sk. Habibul @ Habibul Ansary is using electricity dishonestly by by way of tapping the incoming service cable to bypass the proper registration of units in Energy Meter of WBSSEDCL. Through this bypass arrangement he is using 1No. Electric Iron (400 Watts), 1 No. Ceiling Fan & 1 No. Fluorescent Tube having connected load 0.500 KW. The Service Connection of WBSSEDCL bearing Consumer ID : 242285978 stands recorded in the name of the Accused, which has been disconnected on detection of theft of Electricity. The tariff class of the said connection is Domestic but the accused is using the same for Commercial Purpose.

I prepared Inspection report in presence of the of the Accused and assessed the Load as 0.500 Kw. Details have been mentioned in the Inspection Report and duly signed by the Accused.

I directed the technical persons of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSSEDCL) to disconnect the Service Connection of the above stated Consumer ID. Accordingly they disconnected the aforesaid the aforesaid Service Connection and removed the energy meter with bypass arrangement.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list and obtained the signature of the accused. A copy of the seizure list was handed over to the accused. The Local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection report.

For this activity of theft the WBSSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a), 135(i)(c) & 135 (I) (e) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
