Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Ajit Mahato S/O Lt. Kashinath Mahato of Vill- Dhargram, P.S- Barabazar, Dist- Purulia was enjoying electricity unauthorisedly by illegal hooking from nearest LTOH line with the help of two core PVC cable and he has committed theft of electricity U/S 135(1)/A of the electricity (Amendment act-2007).

On 09.02.2018, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) AMIT SING, S.A.E (E), BARABAZAR CCC, WBSEDCL
- (2) PRADIP SARKAR, O.E., BARABAZAR CCC, WBSEDCL

At About 6:30 P.M., entered into the premises of Ajit Mahato S/O Lt. Kashinath Mahato of Vill- Dhargram, P.S- Barabazar, Dist- Purulia and inspected his shop at Vill- Dhargram, P.S Barabazar, DIST- Purulia.

During inspection, it was found that Ajit Mahato S/O Lt. Kashinath Mahato of Vill- Dhargram, P.S- Barabazar, Dist- Purulia was enjoying electricity illegally hooking from nearest LTOH line with the help of two core PVC cable in his shop at Dhargram, having connected load 0.11 KVA.

From the above arrangement he was using the following arrangements:

01. 01 no electric Bulb (100 watts) with holder.
02. PVC 2 core cable (5 Mtr. App.) along with hooking device.

Out of which I seized the following articles:

01. 01 no electric Bulb (100 watts) with holder.
02. PVC 2 core cable (5 Mtr. App.) along with hooking device.

Seizure list was prepared at site. After process of inspection and seizure list we left the shop at about 6:40 p.m.


