I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act- 2007 , to the effect against Maheswar Mahato S/O Mangal Mahato of Vill- Jilling , P.S- Barabazar , Dist- Purulia was enjoying electricity unauthorizedly by illegal hooking from nearest LTOH line with the help of a two core flexible wire and he has committed theft of electricity U/S 135(1)/A of the electricity (Amendment act-2007).

On 09.02.2018, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) AMIT SING, S.A.E (E), BARABAZAR CCC, WBSEDCL
- (2) CHANDI CHARAN KARMAKAR, C.M, BARABAZAR CCC, WBSEDCL

At About 3.32 P.M., entered into the premises of Maheswar Mahato S/O Mangal Mahato of Vill- Jilling , P.S- Barabazar , Dist- Purulia and inspected his premises.

During inspection, it was found Maheswar Mahato S/O Mangal Mahato of Vill- Jilling, P.S- Barabazar , Dist- Purulia was enjoying electricity illegally hooking from nearest LTOH line with the help of a two core flexible wire in his premises at Jilling, having connected load 0.117 KVA.

From the above arrangement he was using the following arrangements:

01. 01 no electric Bulb (100 watts) with holder.
02. two core flexible wire (22 Mtr. App.).
03. 01 no switch board.

Out of which I seized the following articles:

01. 01 no electric Bulb (100 watts) with holder.
02. two core flexible wire (22 Mtr. App.).
03. 01 no. switch board.

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 3:42 p.m.

The said person has committed an offence U/S 135(1)/A of electricity act 2003 subsequently electricity (Amendment) act- 2007.
