I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect against Biswanath Mahato S/O Kuriram Mahato of Vill- Kashbahal, P.S- Barabazar, Dist- Purulia was enjoying electricity unauthorisedly by illegal hooking from nearest LTOH line with the help of a two(02) nos. single core flexible wire and he has committed theft of electricity U/S 135(1)/A of the electricity (Amendment act-2007).

On 20.03.2018, I Sr ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) AMIT SING, S.A.E (E), BARABAZAR CCC, WBSEDCL
- (2) PRADIP SARKAR, OE, BARABAZAR CCC, WBSEDCL

At About 7:40 P.M., entered into the premises of Biswanath Mahato S/O Kuriram Mahato of Vill- Kashbahal, P.S- Barabazar, Dist- Purulia and inspected his premises.

During inspection, it was found Biswanath Mahato S/O Kuriram Mahato of Vill- Kashbahal, P.S- Barabazar, Dist- Purulia was enjoying electricity illegally hooking from nearest LTOH line with the help of a two core flexible wire in his premises at Jilling, having connected load 0.117 KVA.

From the above arrangement he was using the following arrangements:

01. 01 no electric Bulb (100 watts) with holder.
02. two (02) NOS. Single core flexible wire ( each 12 Mtr. App.).

Out of which I seized the following articles:

01. 01 no electric Bulb (100 watts) with holder.
02. two (02) NOS. Single core flexible wire ( each 12 Mtr. App.).


Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 7:50 p.m.
