Sir, I do hereby lodge a complaint empowered by enabling the Electricity Act 2003 subsequently Electricity (Amendment) Act 2007 to the effect that Durgacharan Mahato (User) s/o Lt Kurnipada Mahato of vill- Rampur, P.O Dargardit, P.S- Boro, Dist- Purnia has committed theft of Electricity v/s 135(1)(b) of the Electricity (Amendment) Act-2007.

It is mentioned that service connection was effected against Renuka Mahato wife of Sri Durgacharan Mahato, having Consumer ID 200898245, MTRN- BR 146239.

On dated 14-03-18 at about 18.00 hr I, Sri Sharup Mandal, AER

Station Manager, Mandara ccc, WBSEDCL, along with

entered the premises of Durgacharan Mahato (User) s/o Lt Kurnipada Mahato of village Rampur, P.O- Dargardit, P.S- Boro, Dist- Purnia and inspected his premises and found that he was enjoying electricity unauthorisedly i.e. by passing of energy meter by cutting of incoming service cable of his wife CON-SD- 200898245.

During inspection theft of electricity was found i.e. he was using electricity dishonestly v/s 135(1)(b) was detected. It was also found that he was using the following electrical equipments.

- 1) 200 watt lamp 1 (one) no.
- 2) Pump 0.5 HP 1 no
- 3) 100 watt lamp 1 no.
- 4) CFL Lamp 20 watt 2 nos.

out of which we seized the following

- 1) 200 watt one no load.
- 2) PVC 2 Core Service Cable with bypassing arrangement 2.5 mt. approx.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 18:20 hrs. on date 14-03-18. The accused person has committed an offence u/s 135(1)(b) of the Electricity (Amendment) Act 2007.

You are requested to take cognizance of the Complaint and treat it as F.I.R and action may be taken as per rule.
