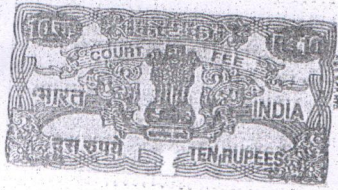
14. Action taken: Since the above report reveals commission of offence(s) u/s 143/447/379/506

The above named Complainant ;  
Most respectfully begs to state :-

- 1) \_\_\_\_\_ That, the Complainant and the accused persons are the resident of same Village.
- 2) \_\_\_\_\_ That, the Complainant has a land bearing R.S. Plot No. 2567, 2568 of Mouza - Manpur having got settlement record in his name having the land in his name having the land in his possession. The Complainant with a view to ~~repair~~ repair his house has cut 20 Bamboo and kept those in his land R.S. Plot No. 2567 and 2568 which are attached each other.
- 3) \_\_\_\_\_ That, on the date of occurrence i.e. on 12/02/18 the Complainant was not in his house went out for Hura Hospital, for the treatment of his wife. Only Sahaban Ansary and Julfikar Ansari were in the house.
- 4) \_\_\_\_\_ That, on 12/02/2018 at about 4 P.M. the all accused person taking advantage of absence of the Complainant have jointly forming an assembly entered into plot No. 2567 and 2568 of the Complainant and started to take away the cut Bamboo poles kept there when the witness Nos. 2 & 3 came out from the house and saw the occurrence. The Witnesses requested to accused No. ~~1~~ to take away the Bambook poles but the all accused persons became ~~very~~ furious started to abuse

and attempted to assault them.

Thereafter the all accused persons taken away 17 Bamboo Poles from R.S. Plot No. 2567 and 2568 forcibly

The accused persons have intentionally committed theft by taking away the 17 Bamboo poles causing a loss of Rs. 2,000/- to the Complainant.

5) \_\_\_\_\_ That, the Complainant came return from Hura Hospital at night on 12/02/2018 and heard about the incident that from witness Nos. 2 & 3, lodged information to Hura P.S. but Hura P.S. Police did not take any action and did not also investigate the same.

6) \_\_\_\_\_ That, thereafter the Complainant lodged Complain in to the S.P. Purulia on 15/02/2018 but S.P. also did not take any step to that effect so, the Complainant compelled to lodge the Complain to this Court.

Hence, it is prayed that your Honour would be pleased to send this petition of Complain to the O/C. Hura P.S. for investigation treating this as F.I.R. U/S. 156(3) Cr.P.C.
