Sub:- Prayer for starting FIR.

Sir,

In producing here with arrested accused namely (1) Shamim Ansary (41 yrs) s/o late Johirun Ansary of Vill Chitra PS Hura Dist Purulia (driver of Vehicle No- WB 55 A -4082 (2) Ayub Kureshi @ Koka (28 yrs) s/o late Jalil Kureshi , of J.K. College Road , Kasaimahalla, Ward No. 8, PS Purulia (T) Dist Purulia, (3) Nasir Kureshi (25 Yrs) s/o Md Basir Kureshi of J.K. College Road , Kasaimahalla, Ward No. 8, PS Purulia (T) Dist Purulia and one seized Vehicle bearing Reg. No. WB 55A/4082(Truck) and 13 (thirteen) buffalos and 5 (five) Cows as per seizure list, do here by lodge a complaint to the effect that today (19/03/18) while I, Jhantu Dalal s/o Lt. Shyamsundar Dalal of 2 No. Shyam Bazar (Aparna Ghat), PO- Nutanganj (Mayurmahal), PS- Burdwan (Sadar), Dist- Purba Burdwan, ASI of Police Hura PS, Dist- Purulia along with C/- 179 Balaram Mondal, C/- 872 Manmatha Hembram and C/- 427 Tapan Kr Sahish of Hura P.S. holding raid as per source information in respect of illegal business of cattle on Purulia - Bankura pitch Road (NH 60A) at Mangalpur near Star Line Hotel under Hura PS and apprehended the above noted accused persons in between 18.05 to 18.55 hrs , along with one Truck loaded with cows as noted in seizure list. On demand they could not produce any valid authority/papers for carrying such cattle. On further interrogation they confessed that they in connivance with Sk Sattar of village Jaynagar PS Purulia (M) Dist Purulia , Fahim Kureshi s/o Naim Kureshi of J.K. College Road , Kasaimahalla, Ward No. 8, PS Purulia (T) Dist Purulia, Sunny Kureshi s/o Doma Kureshi J.K. College Road , Kasaimahalla, Ward No. 8, PS Purulia (T) Dist Purulia and Israfil Kureshi s/o Ismail Kureshi of J.K. College Road , Kasaimahalla, Ward No. 8, PS Purulia (T) Dist Purulia are running this clandestine business of cow since long after collecting those by means of theft from different places of Purulia with carrying those cattle in Truck in such unscientific manner which is painful of those cattle with a view to sale the same at Illambajar cattle Hat, Birbhum, in high price. Hence they are liable for prosecution U/S- 379/411/414 IPC and U/S- 11(1)(d)(e)(f) the prevention of cruelty of Animal Act 1960.

So after obeying all formalities I seized the Trucks loaded with cows after preparing seizure list and also taken them in custody after obeying all formalities and issuing memo of arrest. I am to note here during raid program some of their companion managed to escape from the spot.

I, therefore pray that a case may kindly be started against the arrested accused (1) Shamim Ansary (41 yrs) s/o late Johirun Ansary of Vill Chitra PS Hura Dist Purulia (driver of Vehicle No- WB 55 A -4082 (2) Ayub Kureshi @ Koka (28 yrs) s/o late Jalil Kureshi , of J.K. College Road , Kasaimahalla, Ward No. 8, PS Purulia (T) Dist Purulia, (3) Nasir Kureshi (25 Yrs) s/o Md Basir Kureshi of J.K. College Road , Kasaimahalla, Ward No. 8, PS Purulia (T) Dist Purulia and accused namely 4) Sk Sattar of village Jaynagar PS Purulia (M) Dist Purulia, 5) Fahim Kureshi s/o Naim Kureshi of J.K. College Road , Kasaimahalla, Ward No. 8, PS Purulia (T) Dist Purulia, 6) Sunny Kureshi s/o Doma Kureshi J.K. College Road , Kasaimahalla, Ward No. 8, PS Purulia (T) Dist Purulia and 7) Israfil Kureshi s/o Ismail Kureshi of J.K. College Road , Kasaimahalla, Ward No. 8, PS Purulia (T) Dist Purulia U/S- 379/411/414 IPC and U/S- 11(1)(d)(e)(f) the prevention of cruelty to Animal Act 1960 and arrange its investigation.
