Sir,

In producing herewith the arrested accused person Md. Habib Ansary (38) Driver, S/o. Sarful Haque of Vill.: Jahelitard, P.S. Khalari, Dist. Ranchi (JKD) and one seized Truck vehicle bearing No. CG 07CB 0613 loaded with approx 20 MT of coal to the effect that today (11.03.2018) at 16:45 hrs. myself along with ASI. B. Kalindi and C/1147 Bappaditya Nandi left P.S. for anticrime patrolling duty vide GDE No. 379/18 dt. 11-03-2018 & C.C. No-696/18 date- 11/03/18. At about 18:50 hrs., while myself with force reached at Kansra more, on Jhalda-Gola Road received a source information that one truck having No. CG 07CB 0613 was coming from Gola Jharkhand side towards Jhalda loaded with stolen coal. Accordingly we took our position on road. At about 19:45 hrs. we noticed that the said vehicle coming from Gola side towards Jhalda and at Kansra more we stopped the said vehicle. On asked the driver disclosed his identity as Md. Habib Ansary (38) Driver, S/o. Sarful Haque of Vill.: Jahelitard, P.S. Khalari, Dist. Ranchi (JKD) and stated before me that the Truck was loaded at Rohini Coaliary Ranchi and will be unloaded at Jhalda. He also disclosed that one Aftab Ansary is the owner of the Truck bearing No. CG 07CB 0613 and will be unloaded as per direction of one Lokesh @ Labu. On demand He failed to produce any valid papers in respect of the said vehicle and loaded coal. The driver also confessed that he along with owner of the vehicle and said Lokesh @ Labu were doing such malpractices for their wrongful gain. Hence, There is every reason to believe that the driver owner of the said vehicle and one Lokesh @ Labu with ill motive were transporting coal illegally and thereby liable for offence punishable U/S 379/411/414 IPC. As such at 20:45 hrs. I arrested the accused driver issuing arrest memo and inspection memo, at 20:45 – 21:15 hrs. I also seized the Truck bearing No. CG 07CB 0613 loaded with approx 20 MT of coal under seizure list in presence of my accompanied staff. No public witness was available there.

I therefore pray that kindly start a case against Md. Habib Ansary (38) Driver, S/o. Sarful Haque of Vill.: Jahelitard, P.S. Khalari, Dist. Ranchi (JKD) and Aftab Ansary (Owner) of the said Truck, Lokesh @ Labu who are strongly involved in receiving and dealing with stolen property as per law and arrange for its investigation.
