

Since after few months of marriage and on25.06.2017 and 13.12.2017 and lastly on 17.12.2017 at noon.

F. Place of Occurrence:

At the house of the fathers house of the complainant at Village -Palai, P.O. Itchag, P.S.-Jhalda, Dist- Purulia.

The above name complainant begs to state as follows:-

- That your complainant and witnesses has been residing under P.S.-Jhalda, Dist.- Purulia and the place of occurrence under P. S. Jhalda and within the jurisdiction of this Ld. Court.
- That your was married with one Ganesh Gorain, S/O Basudev
 Gorain of village, P.O. & P.S.Silli, District Ranchi (Jharkhand) on dated
 10.03.2014 as per Hindu rites, rituals and customs prevalent in their
 society.
- That after solemnization of marriage the accd No 1 took your petitioner to his residential house at village, P.O. & P.S. Silli, District Ranchi, (Jharkhand) and started to living there as husband and wife. After expiry of few months of peaceful matrimonial life the accd No 1 and his family members started to demanding further dowry of Rs 25,000/- from your petitioner with an excuse that the accd no 1 intends to set up a business.
- 4. That on this your petitioner started that her father is a poor handicaft personality and at the time of marriage a sum of Rs. 1 Lakh



and gold ornaments five Vories was provided to the accd. No 1 as their demand. The lone amount of which is yet to pay so your petitioner's father in capable to provide further dowry. At this the accd. persons became furious and assaulted your petitioner with fist and blows and drove her out of the house with a command "Jao Taka Nea Eso".

- 5. That reaching at the father's house at village Pilai under P.S.
 Jhalda District Purulia your petitioner narrated or explain the entire facts to her mother, aunty, uncle, grandmother, and father and prayed for money as demand of the in law houses but they showed their unable ness.
- 6. That after a few days the uncle (Jhetha Mosai) of your petitioner took your petitioner back to the in law houses to your petitioner. But having not received the further dowry by the accd. persons as per conspiracy the torture both physical and mental upon your petitioner became intensified.
- 7. That accd. no 3 mother in law used to abuse your petitioner with filthy language and accd no 1 husband of your petitioner with provocation of accd. No. 5 often assaults your petitioner from the association of her husband. Your petitioner tolerated everything with a false hope in her mind good sense will prevail sooner or later.
- 8. That but on 25.06.2017 the torture upon your petitioner reached zenith when upon the provocation of accd. no 6 and 7 and other accused persons assaulted your petitioner mercilessly and drove your petitioner from her in-law house. Since then your petitioner is living with her father's house at village- Pilai, P.S.- Jhalda, Dist- Purulia.
- That thereafter your petitioner filed a misc. case being no.
 180/2017 under Domestic Violence Act which is pending before the Ld. J.M. 1st Class (3rd Court), Purulia in which the next date was
 13.12.2017 fixed for appearance of the above named accd. persons





and said accd. persons appeared before the Ld. J.M. 1st Class (3rd Court) Purulia on the date fixed.

- 10. That as the accd. persons were compelled to attained before the Ld. Court on the Misc Case being no. 180/2017. So the anger of the accd. persons against your petitioners become out of control and on lastly dated 17.12.2017 at noon accd. no.1 husband of your petitioner, accd. no. 4 Jiten Gorain, and accd. no. 6 Budhu Gorain all of a sudden came into the father's house of your petitioners at village- Pilai under P.S.- Jhalda, Dist- Purulia through a motorcycle and assaulted your petitioner with feast and blows on the pretext your petitioner have filled misc case in the court of laws.
- 11. That your petitioner shouted and neighbor came in rescue of your petitioner and send messages to the family members of your petitioner who were at the paddy field and they also come but the accd. persons fled away with a threatening of murder them.
- 12. That thereafter your complainant went to the local P.S. at Jhalda for reported the incident against the above said accd. persons but due to reason better known to the police official of the Jhalda P.S. did not take any action of the said complain. Thereafter on 20.04.2017 your complainant informed the matter to the Superintendent of Police of Purulia but till today not any action has been taken by the police of Jhalda P.S. against the accd. persons. So your complainant takes shelter before your Honours Court.
- 13. That the accd. person have committed the offence and they are liable to be punished accordingly.



14. That your complainant is a poor lady and she has not in position to pull or conduct of the complain case for all such reasons the police case is desirable.

It is therefore prayed that your Honour may graciously be pleased to control the situation and unfold the truth, this complain petition may kindly be sent to the officer-in-charge of Jhalda P.S. to treat this written complain as F.I.R. and to investigate the same U/S- 156(3) Cr.P.C. for the ends of justice.
