Sir,

In producing herewith one arrested accused person namely Haribol Gope (62) S/o Late Mongal Gope of -Joypur Namopara, PS-Joypur, Dist-Purulia, under arrest along with seized articles as per seizer list i.e. 56 (Fifty Six) pieces of plastic bottles country sprit printed as "Dil Khush" on the outer side of the bottles having 600 ML in each bottle in 03 (three) Cartoon Boxes, under proper seizure with label.


I, ASI Susanta Ghosh of Joypur PS hereby lodged a written complaint against the above noted accused person to the effect that today (01/03/2018) at about 06:15 hrs in-course of my anticrime night mobile duty with C/1146 Tapan Pathak, C/340 Baman Das Goswami & NVF/764 Bighuram Gorain all of Joypur PS (Joypur PS GDE No-1202 dated 28/02/18 and CC No- 534/18 dated 28/02/2018), I received a credible source information that the above noted accused person stocked country sprit illegally near Goaladih Village more on Joypur-Hargara Pitch Road under this PS for selling the same during the occasion of holy. On receipt such information we immediately reached there and my source shown the person from a distance, who was ready to selling the liquors at there. We immediately reached there and surrounded him, but other people who were assembled there to purchase liquor, on seeing Police vehicle fled away and found the huge quantity of country sprit "Dil Khush" bottles were kept in 03 (three) "Cartoon Boxes". On searched total 56 (Fifty Six) pieces of country sprit "Dil Khush" bottles were found. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he was ready for selling the same to the villagers of Joypur Namopara, Goaladih, Hargara and adjacent area illegally. So, finding no any other alternative way I seized the above noted articles from the possession of the accused person and labeled, duly singed by the accused person & witnesses in between 06:25 hrs to 06:45 hrs in which one bottle of ID liquor i.e. one 600 ML was kept as sample file with label. During interrogation he confessed his guilt and told that he stocked the same for selling the same during holy festival. As such I arrested him at 06:50 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Haribol Gope (62) S/o Late Mongal Gope of -Joypur Namopara, PS-Joypur, Dist-Purulia u/s-46A (c) of the Bengal Excise Act 1909.


