1. That the complainant and the accused persons are the resident of Village Kalyanpur, P.O. Hinjarishyampur, P.S.

2. That the state of M West Bengal has settled the land bearing R.S. Plot No.485 at Mouza Kalyanpur within P.S.

instead of disburden the crops the complainant sustain servere bleeding injury by the hands of the accused persons. All the accused persons gharowred the complainant and assaulted the complainant with fist and blows and accused sukdeb Mahato assaulted the complainant with a lathi on the head of the complainant as result the complainant gestain bleeding injury and our honting for help hearing halla the meighbouring people came there and sent him to the joypur P.S. othereafter.

The complainant was taken to Joypur hospital the draws to doctor of the said hospital sent the complainant to Purulia Sadar Hospital for better treatment when it here the complainant admitted and released after 3 days.

- 5. That therafter the complainant lodged compalain against the accused person at the Joypur Police Station but no action have been taken from their ends.
- 6. That the matter in very serious in nature.

That the complainant informed the matter to the superintendent of Police Purulia on 1/12/2017 but no action has yet been taken option hence the complainant has no obtain except to make prayer before your Honours Court.
