2. That the state of West Bengal has settled the land bearing R.S. Plot No.485 at Mouza Kalyanpur within P.S. Joypur to the father of the complainant and ~~has~~ <sup>has</sup> given spot possession to the father of the complainant and the father of the complainant after taking possession reclaimed the said land and made it into paddy growing khet and have been possessing the same by growing and reaping paddy crops there in for long more than 30 years.

3. That like previous year, in the year 2017 the father of the complainant transplanted ~~paddy~~ paddy seedling on R. S. Plot No. 485 of Mouza Kalyanpur, which were grown well and in the harvesting season the father of the complainant reaped the paddy with hay and kept in to the sun for drying .

4. That on 13.11.2017 at about 12.0 Clock the complainant went to the aforesaid land in order to ~~reap~~ <sup>gather</sup> the crops which the complainant and his father cut down and kept on the land for drying and have seen the aforesaid accused person in furtherance of their common intention were taking the paddy crops and were going towards their houses. Having seen the incident the complainant raised objection and tried to ~~resist~~ <sup>resist</sup> the accused person but in vain

All the accused persons gharowred the complainant and assaulted the complainant with fist and blows and accused Sukdeb Mahato assaulted the complainant with a lathi on the head of the complainant as result the complainant ~~su~~ sustain bleeding injury and ~~our shouting~~ <sup>shouting</sup> for help hearing halla the neighbouring people came there and sent him to the Joypur P.S. thereafter .

The complainant was taken to Joypur hospital the ~~doxax~~ doctor of the said hospital sent the complainant to Purulia Sadar Hos pital for better treatment ~~where~~ <sup>1W</sup> here the complainant admitted and released after 3 days.

5. That thereafter the complainant lodged ~~complain~~ <sup>g</sup> against the accused person at the Joypur Police Station but no action have been taken from their ends.

6. That the matter in very serious in nature.

That the complainant informed the matter to the superintendent of Police Purulia on 1/12/2017 but no action has yet been taken hence the complainant has no ~~option~~ <sup>option</sup> except to make prayer before your Honours Court . The complainant is submitting application with copy <sup>of</sup> application given to S.P. Purulia.
