I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Bablu Mondal S/O-It.Pramatha Nath Mondal, Vill-Sonaijuri, P.O-Sonaijuri, PS- Kashipur Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 12.03.2018. I received a secret complain over telephone that Sri Bablu Mondal S/O-It.Pramatha Nath Mondal, Vill-Sonaijuri, P.O-Sonaijuri, PS- Kashipur Dist-PURULIA consuming electricity by means of tapping from incoming service cable by unauthorized naked the cable nearest Meter of WBSEDCL.

On the basis of said complaint at about 01.05 pm. I, Sri Mrinal Chowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

1. R. N. Sinha, Special officer, (S&LP),
2. Shankar Ch. Mahato, LM
3. Dayamoy Mahato, TSH all the staff of RM Office, Purulia and
4. Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC
5. Sri Sanjoy Gorain, OE Kashipur CCC.

Entered the premises of Sri Bablu Mondal S/O-It.Pramatha Nath Mondal, Vill-Sonaijuri, P.O-Sonaijuri, PS- Kashipur Dist-PURULIA and found that Sri Bablu Mondal illegally naked the service cable From incoming side for resisting actual consumption in Meter. The existing Meter No- H514216, Make- HE, (Himachal Energy PVT. LTD) con ID-242081359. Then We disconnect his service line from pole, Seized the Meter with cutting point fitted with small portion of service cable with proper seizure list. The seizure list are prepared at the site and the accused person refuse to sign in the seizer list. The inspection team left the above premises at about 1.25 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity. Load found-Fan-3 nos, TV-1 NO, Bulb-3 nos. (0.58 Approx)

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
