I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Kartick Garai S/O-Ilt.Nafar Garai,Vill-Sonaijuri, P.O-Sonaijuri, PS- Kashipur Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 12.03.2018. I received a secret complain over telephone that Sri Kartick Garai S/O-Ilt.Nafar Garai,Vill-Sonaijuri, P.O-Sonaijuri, PS- Kashipur Dist-PURULIA consuming electricity by means of tapping from incoming service cable by unauthorized broken the seal of meter terminal of WBSEDCL .

On the basis of said complaint at about 01.40 pm. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

1. R. N. Sinha, Special officer, (S&LP) ,
2. Shankar Ch. Mahato, LM
3. Dayamoy Mahato, TSH all the staff of RM Office, Purulia and
4. Sri Dipak Kr. Bhowmik, SAE,Kashipur CCC
5. Sri Sanjoy Gorain , OE Kashipur CCC.

Entered the premises of Sri Kartick Garai S/O-Ilt.Nafar Garai,Vill-Sonaijuri, P.O-Sonaijuri, PS- Kashipur Dist-PURULIA and found that Sri Kartick Garai illegally broken the seal and tampering the Meter and using electricity by inserting one piece of cable on incoming side to resist actual consumption . Meter No- B3777790, , Make-BENITEC Electrical and electronics PVT. LTD. con ID-242081367. .Then We disconnect his service line from pole, Seized the Meter with small piece of service cable, one no 15 amp. Board with socket. JJ Make. The seizure list are prepared at the site and the accused person refuse to sign in the seizer list. The inspection team left the above premises at about 2.10 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity. Load found-Fan-4 nos, TV-1 NO, cfl-8 nos.refrigerator-1 no, Pump-1 no (0.94 KW)

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
