I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri\_Subhas Bháttacharjee\_S/O-Lt. Jiban Bhattacharjee, Vill-Indrabill P.O-Gurangdih, PS- Kashipur\_Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003, (Amendment) Act-2007.

On dated 20.03.2018 | received a secret complain over telephone that Sri Subhas Bhattacharjee S/O-Lt. Jiban Bhattacharjee, Vill-Indrabill P.O-Gurangdih, PS- Kashipur Dist-PURULIA consuming electricity by means of tapping from service cable (Incoming side)inside his premises.

On the basis of said complaint at about 01.05 pm. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

Entered the premises of Sri Subhas Bhattacharjee S/O-Lt. Jiban Bhattacharjee, Vill-Indrabill P.O-Gurangdih, PS- Kashipur Dist-PURULIA and found that Sri Sri Subhas Bhattacharjee consuming electricity dishonestly by means of tapping from service cable before entering the meter. The existing connection was in the name of Lt. Jiban Bhattacharjee, con id of exist line-240039639. After death of Jiban Bhattacharjee Sri Subhas Bhattacharjee using the said connection through illegal way by means of tapping. Then we disconnect his service line , seized the cut off point with small portion of service cable, length approx-2 ft. Along with fitted with one top using for bypassing. 1 no bulb with holder and , Load Approx 1.6 KW. After preparation of proper seizure list The seizure list are prepared at the site and the accused person refuse to sign in the seizer list. The inspection team left the above premises at about 1.40 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
