Sir,

In producing herewith one seized vehicle (Tractor) bearing registration No. WB 55A/2197 loaded with sand. The fact of the case in brief is that on 20/03/2018 I along with force were on day mobile duty vide Kashipur PS G.D E No-631, dtd-20/03/18, C.C No-699, dtd-20/03/18 on Kashipur - Sonatholi road. During mobile duty on 20/03/18 at about 14:25 hrs received a credible source information that the above noted Tractor is coming from Sonatholi side towards Kashipur village loaded with sand without valid paper. After receiving this information we were proceeding towards Sonatholi under Kashipur P.S. When we reached near Beliadanga under Kashipur P.S, found that the above noted (Tractor) was coming from Beliadanga village side. On seeing the Police party the driver of the said tractor stopped the tractor in a distance from Beliadanga village near bridge and tried to unload the sand, loaded in the said tractor. We rushed to the tractor and the driver then fled away after keeping the tractor near Bridge at 15:05 hrs. We searched the said tractor and found that the tractor is loaded with sand. I searched for any valid documents in respect of sand loaded in the tractor as well as the valid documents in respect of that tractor but nothing found. Hence I seized the tractor bearing registration No WB 55 A/ 2197 loaded with sand in the trolley amount approx 100CFT of sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging a driver from my source I brought the said tractor to Kashipur P.S. As such there is every reason to believe that the driver and owner of the vehicle bearing registration No WB 55 A/ 2197 with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S- 379/411/414/120B IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of vehicle (Tractor) bearing registration No WB 55 A/ 2197 may kindly be started and arrange for its investigation.
