The above name complainant begs to state as follows:

- 1) That the complainant is the permanent resident of village-Nowahatu, P.S. Kotshila, Dist- Purulia and on 15/01/2018 he along with his wife Sarala Kalindi went to the village Hensalbera under P.S. Kotshila for attending Sradh ceremony of one Kalabati Kalindi.
- 2) That on the date of occurrence i.e. on 16/01/2018 at about 10:00 a while the complainant went at village Hensalbera at that time accused no-1 Pradip Kalindi without any reasons all on a sudden started to assault Malati Kalindi with a piece of wood, seeing such assault the complainant tried to rescue said Malati from the hands of the said Pradip.

At that time there some other two accused persons namely Chitra Kalindi and Parbati Kalindi came to the spot and there are some hot exchange of words in between the parties and in course thereof all the three accused persons are with the piece of wood and other weapon gherowed the complainant and assaulted them mercilessly with the said weapons with a view to murder him.



The accused persons actually assaulted the complainant upon back side of neck just below of the head and nose and other part of the body causing bleeding injuries of his persons.

- 3) That the accused persons actually tried to assault upon the head of the complainant but the blow actually escaped and felt upon the back of the neck for which the life of the complainant has been saved. At the time of incident wife of the complainant namely Sarala Kalindi tried to save her husband's life when the accused persons assaulted her with the said weapons causing injuries on her persons also.
- That the complainant and his wife and daughters somehow managed to left the place and thereafter the came to their native village that time as there was dark they could not arrange for treatment. On the next morning all the above named three injured persons went to Kotshila BPHC and they were treated there by the concerned doctor.
- That the incident was report to the officer-in-charge of local P.S. then the Police of Kotshila P.S. assures that they will take legal action against the accused persons, but due to inaction on the part of the police of the Kotshila P.S. another complaint was lodged to the Superintendent of







Police Purulia but same fate. Hence the complainant is under compelling circumstance filed this complaint before this Ld. Court under the law.

In the circumstances it is therefore, prayed that your honour may be pleased to send the petition of complaint to the Officer-in-charge, Kotshila P.S. treating the same as FIR under section 156(3) for investigation.
