Most respectfully Sheweth :-

- narried wife of the accused person no. 1 and the marriage between them was settled through negotiation and solemnised at her father's house so situated at village Kalimati Tola Loadih, p.S. Baghmundih, District purulia and with in the jurisdiction of your Honour's Court on 10/05/2005 corresponding to 27th day of Baisakh 1412 B.S.
- That although the father of complainant happens 2) to be a old ailing needy rustic villager he by way of taking loan from his friends and relatives had procured money to meet the demand of Rs. 1,50,000/- (Rupees one Lakh fifty thousand) so made on the side of the accused person no. 1 to 8 at the time of settlement of the marriage between the complainant and accused no. 1 Gold ornaments like a pair of gold ear rings waighing about 6 Gms. Gold Mohar, gold nose pin waighing about 4 Gms. were given to the petitioner/ complainant along with lot of sharees, other wearing apparel , Sweaters etc. besides one almirah, Divan, bed beedings, several untensils made of different metals like steel, brass, bell metel etc. Not only that the accused no. 1 was blassed and towards such " Ashirbad " he was given one gold finger Ring waighing about 6 Gms. by his father_in_ Cont d . . . p/ 2; 1 aw.





3) That the petitioner/ complainant after her marriage had stepped into the thereshold of her matrimonial house, So situated at village Chatketa, P.O. Noahatu, P.S. Kotshila, District Purulia, with lot of hopes and drems looked into heart towards leading a happy conjugal life in the joint/ shared house hold properties there at with the accused person no. 1 amidest other in laws.

- 4) That during the introductory days of the petitioner/
 complainant's stay at her matrimonial house the accused

 No._1 used to show longings towards the complainant and the

 rest of the inmates used to shower love and affection towards

 her but the same was a transitory period of about a year.
- blassed with a male child under the paternity of the accused no. 1. Since the birth of their first child the petitioner/ Complainant observed a radical change of the behaviour of the accused no. 1. He started returning home late in the night consuming alcohol almost every day and when the petitioner/ complainant being an ideal Hindu house wife used to ask the reason behind it with a request not to do so or to leave such practice and/or bad habit she had to receive fists and blows from her husband. However the only daughter of the accused no. 1 was born in 2010 through the petitioner/ complainant and for such an offence like







giving birth of a female child she became the eye sore of her husband. The accused no. 1 even did not restrain himself from passing remarks / comments touching the character of the petitioner/ complainant.

- often started compelling her to stay out side the door night long along with their daughter. He often used to hurrl abusive languages aiming out at the complainant & her children in drunken condition. Even at the time when their daughter used to fall ill the accused no... 1 used to ask the complainant to bring money from her father's place for extending the same to her medical care and treatment.
- 7) That the complainant brooked all such torture in anticipation of prospective happiness, but the accused no._1 \$\dagger\$ and others did not mend themselves.
- 8) That the matter reached to its claimex when some time in the month of Falgun 1421 B.S. the accused no.-1 asked the complainant to leave her in laws place along with their children with a plea that he would be given in marriage once again and another bride xx has already been choosen.

 He also stated that her father would hand the bride grooms over a sum of Rs. 2,50,000/- and if the father of the

compainant could undertake to give Rs. 2.50.000/- more






towards aditional dowry then only the petitioner would be allowed to remain at the house of the accused no. 1 to 8 any further and on raising protest over the issue the accused no.-1 in flicted kick upon the lower abdomen of the complainant, resultantly she was fallen sown on the earth. Then the accused no. 1 with the provocation of his parents viz. chhutubabu Mahato and Myanaka Mahato elder brother Anil Mahato, Kajal Mahato Wo. Anil Mahato, Tutun Mahato, S/o. Panchanan Mahato, Sukuri Mahato W/o. Tutun Mahato pressed the throat of the complainant with an intent to kill her by way of strangulation, but the complainant then catching the feets of the accused no. 1 prayed for sparing her life at least for the sake of their children. The accused no. 1 along with his all other inmates as named above will full hatred asked her to leave their house. But when she requested for allowing her to remain at her in laws house the accused no. 1 started assaulting her by means of a stick and her right wrist was fractured, Her all stridhan properties were snatched and she was driven out from her in laws house along with her two children.



- peing frightened taking mobile phone from a passer by informed the matter to her father who had been to vill. Chatkete but was not allowed to enter into the in-laws house of his daughter and finally took his daughter along with her children to his house at Kalimati, F.S. Bagmundi, since the accoused no.-1 and his other inmates held out threats by saying that in case of information regarding such torture before F.S. concerned or before any local body the complainant & her children would never be allowed to remain at the house of the accused no.-1 to 8. The hapless father of the complainant rather on the contrary decided it better to provide treatment locally to his daughter.
 - 10) That the complainant and her father and other relations time and again thereafter requested the accused no. 1 to 8 to return the complainant and her children back to his life and society but all their requests went in vain.

 11) That lastly on 27th day of January, 2018 the complainant came to learn that the accused no. 1 with the active participation of said chhatubabu Mahato, Myanaka Mahato, anil Mahato, Kajal Mahato, Tutun Mahato, Sukuri Mahato and many other co-villagers was given in marriage again with one Sanju

during the sub_sisting marriage with the complainant.


That on the very next date i.e. on 28/01/2018 the complainant had been to her in laws place along with her uncle and she found said sanju Mahato together with the accused no.-1 to 8 and when she asked the indentity of said Sanju She replied that she is the wife of the accused no. 1 who promtly asked the complainant to leave the place readly being a person belongs to schedule Tribe community otherwise he would commit bloodshed over the issue, so informed by him. He further stated that " Tui Nichu Jat Toke Biye Kore amibhul Korechi, chhoto Jat. Amar Bari theke bar hao." More over he informed that his 2nd wife is not barefooted, she stepped into his house after giving a sum of Rs. 2,50,000/- to him. His associates such as prafullya Coswami, Mamata Goswami, Shakti Goswami, Chhita Goswami, Dilip Coswami and sefali Mahato W/o. Dilip Singh Sardar, of the said willage informed her that all of them and many others along with the accused nos. 2 to 8 participated in the






2nd marriage deremony of the accused no...1 and enjoyed the gorgeous marriage receiption party. Finding no alternative hearts she returned to her father's house being broken hearts.

- 13) That several representation so made on the side of the complainant urging for bringing back the complainant along with her children to her matrimonial house was of no effect.
- That the complainant along with her father and her children visited kotshila P. 3. and a x written complaint was duly lodged over the issue depicting every thing what happend but as even after the lapse of 10 days no specific cacase was initiated against the accused persons, the complainant submitted a letter of complaint before superintendent of police, purulia on 06/02/2018 but till date nothing has been effected though the accused persons committed several offences for which they are required to be tried and punished in accordance with law. As the police authority has turned deafear to the complainant's accusations towards the accuseds, the accused persons have becam emboldened.
- 15) That your petitioner/ complainant being hapless lady having no independent income is not in a postition to incure the expenses of a number of complaint cases more over the fact of the case warrent investigation by police agency and





In light of the above it is prayed that your Honour may graciously be pleased to forward the instant petition of complaint to the officer in charge of kotshila P.S. with a direction upon him to investigate into the case threating the same as an F.I.R. under the provision so contemplated under section 156(3) Cr.p.c.
