In producing herewith one accd Sikari Mura (65 Yrs) S/O Lt. Sukhi Mura, of vill-Karior, P.S. – Kotshila Dist – Purulia with seizure of 80 (Eighty) liters illicit spirit contained in 04 (four) Jarican, two used big size handi, One (01) Kg bakar, one iron pipe length about 02 meter, all are used as materials for manufacturing and selling of spirit which was seized under

proper seizure list.

I beg to submit that today (11.03.18) in between 10.25 hrs to 11.35 hrs a raid was conducted in the house of Sikari Mura (65 Yrs) S/O Lt. Sukhi Mura, of vill- Karior, P.S. – Kotshila Dist – Purulia. On acting a secret source information against for unlawful manufacture of spirit and selling of intoxicating drug use and possession of materials for manufacturing of spirit and intoxicating drug, which were manufacturing in the house of accd person. On demand he failed to produced any valid documentary authority in respect of selling and manufacturing of illicit spirit which is kept in four Jarican, two used big size handi, 01 Kg bakar, one iron pipe length about 02 meter from the possession of accd person. Which was seized under proper seizure list which enclosed here with. During arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The above noted arrested accd namely (1) Sikari Mura (65 Yrs) S/O Lt. Sukhi Mura, of vill- Karior, P.S. – Kotshila Dist – Purulia Committed offence u/s- 18 (i) B.E. Act. For possession of intoxicating not obtained from a licensed vendor and in contravention.

It may note here that during raid (01) C /109 Ankur Ch. Mudi, (02) C/ 223 Jiban Mahanty

accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 (a) (b) B.E. Act. 1909 may kindly be started against Sikari Mura (65 Yrs) S/O Lt. Sukhi Mura, of vill- Karior, P.S. – Kotshila Dist – Purulia.
