Dear Sir,

I do hereby lodge complaint empowered by enabling the electricity act-2003 subsequently electricity (Amendment) act- 2007 to the effect that Sri. Manik Ch. Laha was enjoying electricity unauthorizedly i.e. bypassing of energy meter by cutting of incoming service connection cable and due to this reason he has committed theft of electricity U/s 135(I)(b) of the electricity (Amendment act- 2007) on 07/03/18 at 3.10 pm I, Swarup Mondal, A.E & BM, Manbazar CCC, WBSEDCL.

Entered the premises of Sri. Manik Ch. Laha, Vill. Manbazar Prince Road, P.S. Manbazar Dist- Purulia, having Consumer No. 242060898 Meter No. B3763787. and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Heater - 01 no.
- 2) Electric Bulb - 03 nos.
- 3) CFL - 04 nos.
- 4) Electric Fan - 04 nos.

Out of which I seized the following.

- 1) PVC 2 Core Service Connection Cable alongwith By passing arrangement - 3.5 ft (approx).
- 2) Electric Heater - 01 no. 3) Bulb with Holder - 01 no.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 3.30 PM on 07/03/18. The accused person has committed an offence U/S135(I) (a) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.

You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
