Sahadeb Hansda of vill- Jamboni was enjoying electricity by passing from incoming service cable and has committed theft of electricity U/s 135 of the electricity (Amendment act.- 2007) on 27/03/2018 at 1. Sri Anshuman Mitra, AE & SM, Barabazar C.C.C.

Entered the premises of user Sri Sanaranjan Hansda, vill- Jamboni P.S. Manbazar, Dist- Purulia, having Consumer No. 242256298 Meter No. L3614483 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I) (a) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) 01 no bulb (100 watt)
- 2) 02 no single core flexible wire 8 meter (each)
- 3) 01 no holder and 01 no switch
- 4) Single phase meter (5-30A)

Out of which I seized the following.

- 1) 01 no bulb (100 watt)

- 3) 01 no holder and 01 no switch
- 4) Single phase meter (5-30A)

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 4.30 PM on 27/03/18. The accused person has committed an offence U/S135(I) (a) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.


