

Mankasar, Dist Purulia and inspected his premises and found that he was enjoying electricity unauthoritatively i.e. by passing of energy meter by drawing of wire from L.T.O.H line of his connection 242221032.

During inspection theft of electricity was found i.e. he was using electricity dishonestly, u/s 135(i)(b) was detected. It was also found that he was using the following electrical equipments.

- ① Fan 3 nos 60 watt each
- ② Bulb 2 nos 100 watt each
- ③ TV 1 no. 100 watt
- ④ C.F.L. 3 nos 20 watt each
