Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **NARAYAN CHANDRA SINGHA, S/O- LATE KINKAR CHANDRA SINGHA** of Village- SURULIA, P.S.-PARA, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1)(b) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 26.03.2018 at about 11.10AM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Avishek Das SAE(E) of Dubra Para CCC, Lakshman Mahato, HG Sr LM, Dubra Para CCC, Patit Kora HG Sr. TSH of Dubra Para CCC, Sanjoy Prasad, TSH, Dubra Para CCC, WBSEDCL inspected the premises of **NARAYAN CHANDRA SINGHA, S/O- LATE KINKAR CHANDRA SINGHA** of Village-Surulua, P.S.-Para, Dist Purulia. During inspection it was found that the said **NARAYAN CHANDRA SINGHA** was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension overhead line for running his 02 nos motors, approx load 2.25KW for domestic purpose, which is an offence u/s. 135 (1)(b) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 11.30 AM.

As such **NARAYAN CHANDRA SINGHA, S/O- LATE KINKAR CHANDRA SINGHA** of Village-Surulua, P.S.- Para, Dist- Purulia has committed an offence of theft of electricity under section 135 (1)(b) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
