

2...That on the date of occurance i.e. on 4.12.2017 at about 10 A.M. the all accused persons after entering into the house of the complainant abused the complainant in fulthy languages and insulted her by saying 'Daini' and thereafter they called quarrel some ladies namely, Dheli Karmakar w/o Prabhas Karmakar and Chinta Karmakar w/o Gurupada Karmakar of village Manguria and at thi~~r~~ whime the said quarrel some ladies assaulted the complainant with fists and blows and they also uttered the complainants as 'Daini' and Bhutni. The all accused persons in this manner insulted the complainant in the society and they have damaged the respect of the complainant.

3...That by the illegal act of the accused persons the complainant suffered mental agonies and also the respect of the complainant have been damaged. The all accused persons are st~~t~~ill threatening the complainant to oust from the village ~~wk~~ with further threatening if the complainant informs this matter to Police or Panchayat, they will kill the complainant and throu~~sh~~ the dead body to the Rail line.

4...That the complainant informed the matter to Purulia (M) P.S. on 8.12.2017 who assured to start case against the accused persons but nothing has been done and hence the complainant compelled to come before your Honour.
