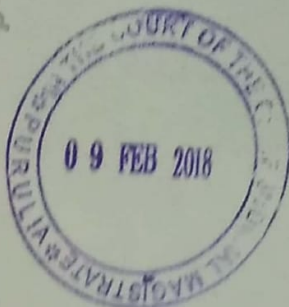

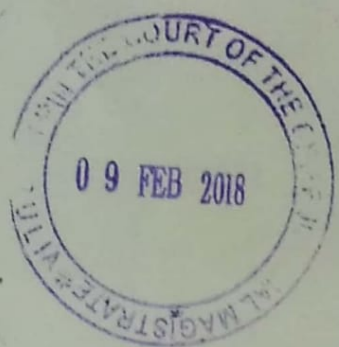

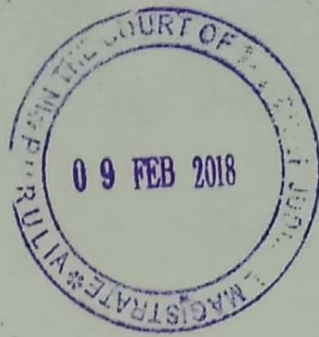
3. That after marriage the complainant was taken to her matrimonial house by the accused person and started to reside there as husband and wife with the accused no.1 along with other accused persons in the same mess and house.

4. That in the meantime the complainant gave birth three children namely sahid Ansari Lilun Khatoon and Samir Ansary .

5. That the complainant begs to submit that from the very beginning of the marriage the accused persons started torture both physically and mentally but the complainant liw there bearing all such torture .

6. That after the third issue of the complainant her husband Nurmohammed Ansary Bhasur Saigul Ansary and Jaa Arajan Bibi created presure upon the complainant

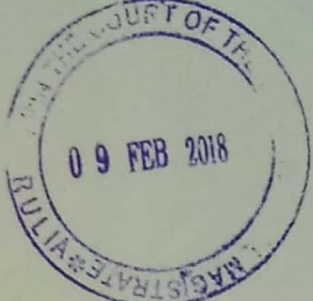
to bring Rs. 20,000/- only by way of further doury and contrary to that they will not allow the complainant to stay in their house however the complainant bearing all such torture managed to stay at her matrimonial house at Village Sihali.

7. That on 20.12.2017 at about 7.00 P.M. accused Saidul Ansary came near to the complainant and gave her an ill proposal in which the complainant raised objection then and there accused Saidul Ansary assaulted the complainant with fist and blows and also caught hold the hair of the complainant and assaulted her mercilessly hearing hue and cry neighbouring people came to the house of the accused person but the accused Saidul Ansary along with Jarina Bibi drove the complainant from their house finding no other alternative the complainant of first came to her brothers house at Village Lagda tola Islandih there after the complainant has gone to her fathers house at Village Naranpur and as passing her days with great hardship.

8. That the matter is very serious in nature and as such the complainant went to Purulia (M) Police Station
