I Sri Prashant Kishor, S/O - Kishori Prasad, A.E. & Station Manager of Telkalpara CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Ananda Kuiry S/O Lt. Atul Kuiry of Vill - Bhul, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 08.03.2018 I, Prashant Kishor (AE&SM), along with Sri Chintoy Maity, SAE(E), & Sri Debdulal Banerjee, Sr. TSH of Telkalpara CCC, WBSEDCL conducted a raid programme at village Bhul under Purulia(M) P.S. When our team at about 12.00 P.M. entered to the Agriculture premises of Ananda Kuiry, we found that he was enjoying electricity dishonestly by means of Direct Hooking From Nearest LTOH Line and run water Pump motor set for agricultural purpose, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 12.30 P.M. after completion of inspection & necessary formalities.

Ananda Kuiry S/O Lt. Atul Kuiry of Vill - Bhul, PS-Purulia(M) has committed the theft of electricity under section 135(1)(a) of the Electricity (Amendment) Act-2007.
