Sir,

1 S1 Gopal Chandra Man of Purulia (M) PS, Dist Purulia do hereby lodge a complaint against (1) Somya Sankha Ojha S/O Deb Kumar Ojha of Hutmura, P.S Purulia(M), Dist. Purulia (2) Goutam Ojha S/O Late Haridas Ojha of do (3) Sanjoy Gorai S/O unknown of Hutmura (4) Sumit Bid S/O Asoke Bid of Joynagar, P.S Purulia(M), Dist. Purulia (5) Daktar Ojha @ Krishnendu S/O Arun Ojha of do (6) Dharanidhar Paramanik S/O Bhikkhakar Paramanik of Sidpur, P.S Purulia(M), Dist. Purulia (7) Achintya Gorai S/O Kanai Gorai of Bhabanipur, P.S Purulia(M), Dist. Purulia,(8) Sukumar Bouri S/O not known of Singhbazar, P.S Purulia(M), Dist. Purulia and 100 others that today (08.03.18) at 11:35 hrs duty officer of Purulia(M)P.S received information regarding gathering of people at Hutmura bazar near Durga mandir on Purulia-Bankura National Highway (NH 60A) and blocked the said Highway. This refers to Purulia (M) P.S GDE No. 350, dtd. 08.03.18. As per direction of O/C, Purulia(M) P.S I S.I Gopal Ch. Man alongwith, ASI Basudeb Ojha and force of Purulia (M) P.S left for Hutmura to work out the information. On way S.I Lakshmi Kanta Pati and force of Mobile duty-II and S.I Haradhan Mahadani and force of mobile duty-I met with me to assist for maintaing Law & order at Hutmura. On reaching at spot found that the above noted persons and 100 others people of Hutmura G.P and Agya- Narrah G.P had obstructed the Purulia-Bankura (NH 60A) at Hutmura bazar near Durga Mandir and vehicular traffic was disrupted. On going buses, Trucks and other vehicles were stopped. They raised slogans against police over the issue of incident occurred at Deouli Mela on 06.03.18 night. Myself alongwith officers tried to convince among the people and requested to withdraw the road blocked but they did not pay any heed rather than the mob became continuing their business. Finding no other alternative, I declared them as un-lawfull assembly and asked them to disperse though they did not pay any attention. After prolonged discussion with them they withdrew the road bolcked at 13: 25 hrs, and decamped calmly. Vehicular traffic became normal.

As those persons have committed an offence u/s 143/341/186//283/506 I.P.C and 18 West Bengal Highway Act. 1964. Hence I submitted a complaint with a prayer to start a specific case.
