To The Officer-in-Charge Purulia(M) PS Purulia

I. SI Dhirendra Nath Mandal of DEB, Purulia do here by lodged a written complaint seing produced the accused Bibhuti Bhusan Singh(58yrs.) s/o Lt. Manmatha Nath Singh of Sindri Chas More, PS Purulia(M), Dist Purulia alongwith the seized articles (i) 04 barrel of K.Oil containing 220 ltrs. each (ii) 06 plastic jerricans containing 50 ltrs. each (iii) 08 plastic jerricans containing 20 ltrs. each, total approx 1340ltrs. of Kerosene Oil loaded with vehicle No. WB55/8284 with proper seizure list as well as Memo of Arrest including relevant documents to the effect that today 09.03.18 at 18:45hrs. received a credible source information to the effect that one Bibhuti Bhusan Singh with vehicle No. WB55/8284 loaded with K.Oil will proceed towards chas more for illegal business purpose. Hence, being directed by Dy.SP(DEB), Purulia myself alongwith C/72 Sribas Mahato & HG/1503 Shyamapada Mahato all of DEB, Purulia had been to Purulia-Jhalda road to work out the information after noting the fact vide Purulia(M) PS GDE No.435 dtd. 09/03/18. On arrival near Sidhu Kanu Birsa University, Purulia myself with force waiting some times and observed the above vehicle was proceeding towards chas more. I managed to detained the vehicle. On searching I found the vehicle is loaded with K.Oil as noted above. On asking the occupant of the vehicle, disclosed his identity, as Bibhuti Bhusan Singh(58yrs.) s/o Lt. Manmatha Nath Singh of Sindri Chas More, PS Purulia(M), Dist Purulia but he failed to produce any valid documents / papers in respect of loaded above articles. On being asked the accused person Bibhuti Bhusan Singh stated that he procured this Kerosene Oil from one Anup Bajaj, a big kerosene dealer of Manguria near Petrol pump, Manguria, Purulia. Hence there is sufficient reason to believe that the above noted accused person making connivance with Kerosene dealer procured the said K.Oil by illegal means and he carrying the same for clandestine business with a view to earn money by illegal way by depriving the genuine poor ration card holder.

Accordingly I seized the above noted vehicle loaded with 1340 ltrs.(approx) K.Oil from his possession with proper seizure list and arrested the accused after maintaining all legal formalities regarding arrest. Communicated grounds of arrest.

Therefore, I pray kindly start a case under section 7(i)(a)(ii) of Act X/1955 & 120B IPC for violation of West Bengal Kerosene Control Order 1968. As per order of Dy.SP,DEB, Purulia SI Sajal Mishra has already taken up its investigation.
