Sir, respectfully, I Sri Jiten Bauri, S/o Late Narendra Bauri, a permanent resident of Raghobpur, P.O. & Village Raghobpur, Dist. Pursulia (WB), beg to draw your kind attention, that today i.e. on 13/3/18 I attended one meeting called by Bauri Samaj, held at Rabindra Bhawan, Pursulia, after parking my Motor-bike (Hero HF Deluxe 100cc having Regn.
