In producing herewith the arrested accused persons Jitesh Sharma (25 yrs) s/o Garilal Sharma of Jairampur, PS- Tisra, Dist- Dhanbad, Jharkhand, driver of Dumper having No. JH10AG 6259 loaded with stolen steam coal approx 10 tons with above noted vehicle. Fact of the case in brief is that on 21.03.2018 myself along with C/222, Samar Nandi & HG/1454, Prakash Char who were on special mobile duty (Purulia (T) PS GDE No 1145 dated 21.03.2018 & CC No 833/18) on Purulia town area and received a source information that the above noted vehicle is coming loaded with steam coal from Dhanbad side towards Tata side via Purulia. After receiving this information we had been to NH 18 road at Judge Bunglow morh and found that the above noted vehicle loaded with steam coal is coming from Dhanbad side. We stopped the said vehicles and on search found the Dumper is loaded with steam coal. Asked the driver to produce the documents in respect of said steam coal as well as papers in respect of his vehicle and his driving license but he failed to produce the papers and driving license. He also stated that the said coal was loaded from Dhanbad area. The driver also confessed his guilt implicating himself and owner of the said vehicle who were involved into this case. The driver also stated that they are running a clandestine business through this coal for wrongful gain and they are habitual to running this business. As such it is every reason to believe that the driver, owner of the said Dumper having No. JH10AG 6259 with ill motive were transporting steam coal illegally and they are liable for offence punishable U/S 379/411/413/414 IPC. As such at 23:05 hrs (21.03.18) I arrested the accused person Jitesh Sharma (25 yrs) s/o Garilal Sharma of Jairampur, PS- Tisra, Dist- Dhanbad, Jharkhand, driver of Dumper having No JH10AG 6259 issuing arrest memo and inspection memo, observing other guide lines of Supreme Court and Human Rights Commission. I also seized the Dumper having No. JH10AG 6259 loaded with approx 10 Tons Steam Coal preparing seizure list in presence of my accompanied staffs. No public witness was available there.

I therefore pray that kindly start a case against accused person namely Jitesh Sharma (25 yrs) s/o Garilal Sharma of Jairampur, PS- Tisra, Dist- Dhanbad, Jharkhand driver of Dumper having No. JH10AG 6259, owner of the said Dumper as per law and arrange for its investigation.
