





The complainant above named begs to state as follows:-

- 1. That the accused person Lohariwalla offered to sale the land described in schedule below and the complainant agreed to purchase the same and accordingly an agreement was made between them in the year of 2007. As per said agreement, the complainant gave sum of Rs, 3,00,000/=(three lakh to the accused person in the year of 2007 as a consideration amount and after receiving the said amount, the accused person gave possession of the said house to the complainant. The complainant used to possess the said land/house as a godown, and the complainant kept some valuable articles amounting Rs, 50/60 thousand in the said house/godown. The said godown was a under lock and key of the complainant.
- 2. That the complainant requested the accused person in several time to executed a regd sale deed in favour of the complainant in respect of the land described below but the accused person has intentionally deferred the matter for the reason best known to him. The complainant has compelled to file a Title Suit against the accused person before the court of Ld. civil Judge (Sr. Div.) at Purulia. The said suit was registered as T.S. No. 183/2017. After receiving the said summons the accused person became angry.

- at about 8 A.M. the accused person forcibly entered in the godown of the complainant after the lock and max he took away the entire valuable articles i.e. xerox papers . ink etc from the said godown of the complainant. The complainant raised objection against the illegal activities of the accused person but he threatened to the complainant in a dire consequences. The complainant has sustained loss of Rs. 60.000/= only. The complainant reported the matter to the witnesses and the witnesses also saw the occurance.
 - 4. That thereafter the complainant reported the matter to the O/C Purulia(T) p.s. but O/C Purulia (T) p.s. did not take any action against the accused person till today. The complainant also reported the matter to the S.P. Purulia on 10.1.2018 but till today police did not take any steps against the accused person so the complainant has been compelled to file this case before your Honour court.
 - 5. That the complainant is a poor man and there is a question of search and seizure which can not be done in the basis of complaint case so for the ends of justice the police case is desirable.


