That out of grudge, in order to take revenge upon the Accd. persons complet. just to fulfill the ulterior motive, all on sudden enter into the disputed plot for creating mix nuisance and mischief over the disputed land in which complt raised protest whereupon all the Accd. persons grew furious in Red teeth & claws and having armed with Axe, iron Rod and Lathi followed the complt. entered & into the Bastu of the complt at the relevant point of time and threatend the complt. and his family members with dire consequences with uttering " আপো তোমাৰ মুভে শেখ-কৰিব। কৰাবলগী, মনু দীৰ্ঘ মুভে আৰা। "

That complt and his other family members any how escaped from the clutches of the Accd. person and saved themselves from the dagger point of the Accd. persons otherwise Accd. could have finished the life of the complt. Accd. in furtherance of common intention had entered into the house of Compt. along with deadly weapons just to commit crime as well to cause grievous hurt upon Compt. and his other family members.

That the complt. lodged a written complaint against the Accd. persons owing their illegal act with Raghunathpur P.S. on 14-11-2017 in which P.S. concern also assured the complt. to took into the matter and to take legal action against the accd person but in vain as a result complt. sent his grievances through the Regd. post on 16-11-2017 to S.P. Purulia but till date no legal action has been initiated against Accd. persons as result accd. persons are loitering in the locality disclosing that no one can do any thing against them due to their high handed action.
