Subj: - regarding Criminal Breach of Trust and Dishonest Misappropriation -
in respect of Property of Bar Association, Raghunathpur by the Ex-Secretary
Shri Tapan Kumar Majeed Shri Narayanas Mukherjee of Raghunathpur, Bar Association.

Sir, I, Shri Gopal Krishna Acharya, the Present Secretary of Bar Association -
Raghunathpur, do hereby, lodging this P.R. against the Ex-Secretary of our
Bar Association for his illegal act during his tenure which runs as follows:-
1) That after taking charge of our Bar Association, Raghunathpur I came to
my ~~knowledge~~ notice that out of 11 (Eleven) old Iron Beams of (nine) Pieces
of old Iron Beams are found missing. on enquiry from the Present
Bar Association Sukumar Sarkar who informed me on 16/2/2018 that the
Ex-Secretary Shri Tapan Kumar Majeed has already sold 11 (Eleven) Pieces of
old Iron Beams to 1) Shri Sachin Mukherjee Shri late Fakir Mukherjee -
and 2) Shri Nityananda Goswami Shri late Murali Goswami, resident of Raghunathpur
P.O., S. Raghunathpur, Dist Purulia without any resolution of our Bar Association
or permission of the Bar. But out of 11 (Eleven) Pieces of old Iron Beams
9 (Nine) Pieces old Beams were removed and 2 (Two) Pieces of old Beams
are still attached with the roof of the Damaged Building.

2) That said Tapan Kumar Majeed being the Secretary has entrusted with
the Property of the Bar Association including the 11 (Eleven) Pieces of old
Iron Beams and he had dominion over the aforesaid 11 (Eleven)
Pieces of old Iron Beams dishonestly misappropriated and disposed -
the said Property in violation of any resolution or direction
of the Bar Association Raghunathpur.
