Entered the premises of HARA Bauri, s/o- Srihari Bauri Vill Toldhi
P.S. Raghunathpur, Dist- Purulia, having Consumer No. 242088979 Meter No. 750131631

and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I) (b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) PVC 2 core cable with tapping part of 6mm cable approx- 9ft approx
- 2) Bulb with holder - 01 Nos
- 3) Freeze - 01
- 4) Bulb - 03, Fan - 02

Out of which I seized the following

- 1) PVC cable with tapping part of 6mm cable approx 9ft approx
- 2) Bulb with holder - 01 Nos

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 1:30 pm on 09/03/18. The accused person has committed an offence U/S135(I) (a) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
