Entered the premises of Hare Bauri, S/o - Srihari Bauri, Vill - Toldhu
P.S. Raghunathpur, Dist- Purulia, having Consumer No. 24008977, Meter No. 750131631
and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I) (b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

- From the above by-passing system he/she uses the following electrical equipments.
- 1) PVC Cable with tapping part of service cable abt - 9 ft apart
 - 2) Bulb anti holder - 01 Nos.
 - 3) Fuse - 01
 - 4) Bulb - 03, Fan - 02

- Out of which I seized the following
- 1) PVC Cable with tapping part of service cable abt long 9 ft (approx)
 - 2) Bulb with holder - 01 Nos.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 1.30 P.M. on 09/03/18. The accused person has committed an offence U/S135(I) (a) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
