While inspecting the Deemed Disconnected consumer premises along with the Divisional Manager, Raghunathpur Division, WBSEDCL at Agubari Village, we have found an abnormal cable entering in the consumer premises of Dipak Mandal, S/o - Lt Jyotilal Mandal. Hence, I do hereby lodge complaint empowered by enabling The Electricity Act-2003, Subsequently Electricity (Amendment) Act-2007 to the effect that Dipak Mandal was enjoying electricity unauthorisedly i.e. hooking from nearest L.T.O.H line and due to that reason he

has committed theft of electricity U/S 135 of The Electricity (amendment Act-2007).
