Respected Sir,

In producing here with arrested accused person namely Ajit Mal (aged approx 52 yrs) S/O Lt. Foni Mal of vill- Baranti, P.S. Santuri, Dist. Purulia along with seized Country Spirit bottles ( details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 16:25 hrs I received a credible source information that one person namely Ajit Mal S/O Lt. Foni Mal of vill- Baranti, P.S. Santuri, Dist. Purulia is stocking and selling Country Spirit bottles without any valid license from his house at vill-Baranti, P.O- Muradih, P.S. Santuri, Dist. Purulia, this refers to Santuri P.S. GDE No. 333/18 Dtd: 08.03.18. Accordingly, I along with force (C/597 Nishanath Mukherjee & JC-795 Somnath Singha Mahapatra both are of Santuri P.S.) vide Santuri P.S. C.C. No. 840/18 Dtd: 08.03.18. left P.S. for vill. Baranti to work out the said source information and held raid into the premises of above mentioned accused person. During search with the help of accompany force, we found that the said person is stocking & selling Country Spirit bottles. Being asked, he discloses that all those Country Spirit bottles have been stocked for the purpose of sell. On demand, he failed to produce any valid documents/ License in respect of stocking and selling of Country Spirit bottles. Accordingly, , I seized all the sealed Country Spirit bottles (details in attached seizure list) after preparing proper seizure list duly signed by the witnesses. One sealed C.S. bottle has been kept & labeled as sample bottle. Total 27 liter Country Spirit has been seized, total value of the seized Country Spirit is Rs- 1575/= (One thousand five hundred and seventy five only). Then, I arrest him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him.

Under the above circumstances and fact, I therefore pray that a cog. case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Ajit Mal S/O Lt. Foni Mal of vill-Baranti, P.S. Santuri, Dist. Purulia and arrange for its investigation.
