Sub: Complaint against Khokan Paramanik (45 Yrs) S/O- Lt. Ratan Paramanik, of Vill- Kotaldih, (Ranga Danga), PS- Santuri, Dist- Purulia to start a cog case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing here with the arrested accused person namely Khokan Paramanik (45Yrs) S/O- Lt. Ratan Paramanik, of Vill- Kotaldih (Ranga Danga), PS- Santuri, Dist- Purulia along with seized Country Spirit & Foreign Liquor bottles (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 19.45 hrs received a credible source information that one person namely Khokan Paramanik S/O- Lt. Ratan Paramanik, of Vill- Kotaldih (Ranga Danga), PS- Santuri, Dist- Purulia is stocking and selling Country Spirit & Foreign Liquor without any valid license from his dwelling house at Vill- Kotaldih near Ranga Danga, P.S - Santuri, Dist - Purulia. Accordingly, I along with force had been to the spot for Kotaldih (Ranga Danga) to work out the source information and held raid into the premises of above mentioned accused person. I like to note here that seeing the Police personnel, customers were fled away. During search with the help of accompany force, we found that the said person is stocking Country Spirit bottles & Foreign Liquor for sell. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of Country Spirit & Foreign Liquor bottles. Accordingly, I arrest him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized all the sealed Country Spirit & Foreign Liquor bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample bottles. Total 12 liter Country Spirit & 720 ml Foreign Liquor has been seized, total value of the seized Country Spirit & Foreign Liquor is Rs- (700+400)= 1100/= (One thousand one hundred only).

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Khokan Paramanik (45Yrs) S/O- Lt. Ratan Paramanik, of Vill- Kotaldih (Ranga Danga), PS- Santuri, Dist- Purulia and arrange for its investigation.
