Entered the premises of Sri TUFAN KR MONDAL, S.O- SANTOSH KR MONDAL of Village- JIARA, P.O-ADRA, P.S-ADRA, Dist- Purulia.and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly By **BYPASSING FROM THE INCOMING SERVICE CABLE BEFORE ENERGY METER** i.e. U/S 135/1/A was detected.

From the above system he/she was using the following Electrical equipments i.e.  
SIX CEILING FAN'S, SIX LIGHT'S,ONE PUMP

Out of which we seized the following:

APPROX. 01 MTR DOUBLE CORE PVC CABLE WITH THE BYPASSING ARRANGEMENT.

The seizure list is prepared at the site and the accused person signed in the seizer list

The inspection team left the above premises at about 01:20 PM on dated 04.04.2018.The accused person has committed an offence U/S-135(ii)(a) of the Electricity (Amendment) Act-2007.
