The above named complainant begs to state;

1. That the complainant has married one Sabita Goral w/o Sanjoy Goral of Vill. Hensla on 16.3.2017 as a registry under Spl. Marriage Act, marriage at Purulia registry office certificate no. 95/17. In that marriage the parents and brother of Sabita were not satisfied.
2. That after marriage, Sabita came to the house of the complainant and started to live with the complainant as husband and wife peacefully.
3. That on 1.4.2017 the all accused persons came and took Sabita to their house at Hensla village and used to give threat her by saying that, they we will arrange for the marriage of Sabita with another boy at Bokaro, but Sabita did not agree to the proposal of the accused persons.
4. That the all accused persons kept her in concealment, they did not allow her to move freely to talk, not to come out side of house. They have assaulted her for several times they threaten her for to leave Bikash and other members of her matrimonial house, not to talk with them, not to keep any contact/relation with them and to forget her matrimonial house for ever.
5. That the all accused persons have kept Sabita in confinement and to compell her marriage with another

boy though she is the legally married wife of the complainant.

6. That Sabita Gorai has lodged complain ~~ka~~ into the S.P. Purulia against her parents brother i.e. against all accused persons on 20.7.2017. stating all the tortures inflicting upon her at her father's house.

7. That at present Sabita is at her father's house in confinement of the accused persons and they are trying to arrange for the second marriage of Sabita during the subsistence of marriage with the complainant. The complainant went to Hensla to bring Sabita to his house but the accused persons have abused him in filthy languages and attempted to assault.

8. That the all accused persons have kidnapped Sabita with intend to secretary and wrongfully confine. They are trying the kidnapped person to compell her marriage, against her will. They have kept Sabita in conceal and in confinement.

9. That the complainant has lodged complain to O.C. Arsha P.S. and thereafter to S.P. Purulia but till date no specific case has been started against the accused persons and hence this complain.
