The humble complainant on behalf of the complainant:-

Most respectfully sheweth:-

1. That, the paternal house of the complainant is situated at village Simultar within Kenda P.S. and she is permanent resident of that village. Her father died prior to the solemnization of the marriage of the complainant and her widow mother and elder brother had arranged the marriage of the complainant.

2. That, the marriage in between the complainant and the accused no. 1 Akhtar Ansary was solemnized in the month of Jaisthya i. e. 9th Jaisthya in the English calendar of 2001 as per Muslim rites and customs prevalent in the community . At the time of marriage 'Den Mohor' was fixed of Rs. 10,551/- (Ten thousand five hundred fifty only and as per demand of the accused no. 1 and his pa

some gold and silver ornaments were given to the complainant by her widow mother and some articles were given as a 'Dan Samstree' by the family members of the complainant.

3. That, after marriage the complainant went to her matrimonial house at village Pithati within P.S. Arsha, Dist. Purulia being accompanied by her husband Akhtar Ansary and started living as husband and wife. After marriage when the complainant had entered into her matrimonial house she found all the accused persons used to live in the said house in a joint mess. Accordingly the marriage was duly consummated. As a matter of fact on the following day of the said marriage the marriage in between Sazim Ansary (elder brother of the complainant and Khadiza Bibi (daughter of Alijan Ansary) of Pithati P.S. Arsha, Dist. Purulia was solemnized and after marriage Sazim Ansary had taken his wife to my father's house at village Simultar within P.S. Kendra, Dist. Purulia and started living as husband and wife.

4. That, out of the wedlock the complainant gave birth to three daughter and one male child, in which Asgar Ansari (the male child) was born on 14.10.2002 at vill. Simultar. The second issue, namely Arjahan Khatoon (the female issue) was born on 20.08.2005, Marjina Khatoon, the

female issue was born on 10.04.2007, and Anisa Parveen was born on 01.01.2008, all the children except Marjine Khatoon are under the custody or supervision of the complainant.

5. That, the complainant beg to submit that after the birth of the the first issue (the male child) Asgar Ansary , the complainant was not behaved properly by all the accused persons and she was subjected to physical and mental torture including physical assault and also caused various manner of cruelty including various harassment upon the complainant. The complainant was pressurised by her husband with the direct assistance of other accused persons to bring Rs. 50,000/- from her father's house add whenever the complainant expressed her inability to fulfil the same as the complainant's family belonged to a poor family in which the widow mother any how managed to maintain the day to day expense of the family , but unfortunately the accused no. 1 did not pay any heed and started assaulted upon her with the direct assistance and instigation of other accused person too.

6. That, the complainant how ever tried to lead her conjugal life with her husband and other in-laws and also made sincere efforts to lead her conjugal life

peacefully and also tried to convince them that it is not possible for her to bring such a heavy amount from her widow mother but instead of so any good gesture or ~~made~~ mend themselves they openly disclosed that unless and until the same is being fulfilled she was allowed to stay at her matrimonial house, unless the demand of Rs. 50,000/- be fulfilled. In such perspective the physical and mental torture including the physical assault which was started after covering one year from the date of marriage and the same has increased day by day and all the accused persons took active part in causing harassment and cruelty upon the complainant. In some occasion the accused no. 1 being assistance by other accused persons drove her out from her matrimonial house and she was forced to leave her matrimonial house and on some occasion she was forced to sleep in the night out side of the house. The complainant however has accepted every thing with an expectation that one day the situation will be definitely changed but rather the situation has deteriorated day by day. The accused no. 1 also on some occasion provoke the complainant to commit suicide so that the accused no. 1 can marry for the second time. The complainant however has taken delicate situation and tried to live at her matrimonial house .

7. That, inspite of receiving such physical and mental torture by the complainant she prior to adjust herself at her matrimonial house and has continued her sincere efforts for leading her conjugal life peacefully on the expectation that the supervision and welfare of the children which is most paramount consideration is required to be very carefully maintained and for which she used to stay at her matrimonial house, but unfortunately the degree of torture has increased day by day and the climax has reached in such a stage that on some occasion the complainant thought it put her end of her life but considering the age of the children she resist herself. Her husband never give any dignity of a house wife and other in-laws also flatly denied to give any status of a house wife and ultimately on the fateful day i.e. 'Makar Sankranti' of this year, the accused no. 1 being accompanied by other accused person pressurised the complainant to meet the demand of Rs. 50,000/- (fifty thousand) and whenever the complainant expressed her ~~her~~ inability to fulfill the same the accused no. 1 assaulted her by fist and blow and her Bhasur and two Debars also took active part in assault upon the complainant and other accused person also took active part for instigation them and all the accused persons jointly and forceably drove the com-

complainant from her matrimonial house with all the children and they forceably keep one daughter of the complainant namely Marjina Khatoon in their custody and finding no other alternative the complainant had to take shelter at her father's house with other children and since then she is residing at her father's house with utmost difficulty. As a matter of fact during her whole span of conjugal life the physical and mental torture including physical assault and other harassment which started after one year from the date of her marriage and the same was continued till the last of driven out i.e. 'Makar Sankranti' of this year. whenever the complainant used to visit her father's house on all occasion she disclosed the role of the accused persons and the post marriage illegal demand of all the accused persons and she has faced various types of harassment including physical assault caused by the accused persons. The family members of the complainant also console her and also advice the complainant to continue the conjugal relationship with the accused persons. When the complainant lastly drove her out from her matrimonial house the complainant and her family members also tried to settle the matter amicably so that the complainant can lead her conjugal life peacefully at her matrimonial house

but the accused persons not only allowed the complainant to enter into her house they jointly threatened them with dire consequences. In such back drop the complainant is residing at her father's house with her children with much difficulties.

8. That, the complainant being accompanied by her elder brother had been to Arsha P.S. to lodge a complaint against all the accused persons for taking legal action against them and the O.C. Arsha P.S. assured the complainant that he would take legal action against them but still now no action has yet been taken, no specific case is registered and the complainant thereafter submitted a memorandum of appeal addressing the Superintendent of Police, Purulia on 16.02.18 and still then no specific case has been registered against all the accused persons. The complainant is a poor woman, having no source of income and it is not possible for to conduct the case by engaging a lawyer and for which the present complaint has been filed before your honour's court with a prayer to send the said complaint to the o.c. Arsha P.S. for causing investigation as contemplated u/s 156(3) Cr.P.C. after treating the complaint as F.I.R. and the prayer of the complainant may be considered favourably.
