I EX S.M. Ramsankar Mishra of CIAT School Salua, PS-Kharagpur (Local), Dist-Paschim Medinipur as contractual trainer of said school lodge a complaint before you that today i.e. 21.04.2018 at 09.45 hrs myself along with base team approaching towards base camp at Upper Dam for supplying logistic materials by vehicle no- WB 36D/4556 (Bolero MAX) of EFR 1st Bn At that time one TATA -407 bearing registration no- WB 55/5614 which was coming from Upper dam side in excessive speed directly met head on collision with our Govt. vehicle no WB 56D/4556 due to rash & negligent driving of both the driver of the offending vehicle. As a result HAV-Rishal Sinha and EX HC-Dipankar Thakur sustained greivous injuries on their person and they were being treated at Pathardih BPHC. Both the offending vehicle were badly damaged.

I therefore pray before you that action against both the offending vehicles driver be taken as per law.
